


Figure I. U.S. R&D Expenditures by Source of Funding, 1956-2020


Figure 2. Federal and Business Shares of U.S. R&D Expenditures, 1956-2020

Foundations: Mission, Types, 501(c)(3) Status

501(c)(3) Tax Exempt Organizations

To be tax exempt

- Defined in Section 501(c)(3) of the Internal Revenue Code
- Organized and operated exclusively for exempt purposes set forth in section 501(c)(3)
- May not use any of its earnings to benefit private shareholder or individual
- May not campaign for or against political candidates
- Are restricted in how much political and legislative (lobbying) activities they may conduct

501(c)(3) Tax Exempt Organizations

Non-Profits

- A wide variety of activities, including charity and making grants
- Charitable, religious, educational, scientific, literary, testing for public safety...
 May make grants

Charitable Organizations

- A subset of 501(c)(3) organization
- Have an IRS definition

Foundations

- Not a legal definition
- Typically, charitable organizations that make funding to others

IRS-Defined Charitable Purposes: Compare with MSU's Goals

- "relief of the poor, the distressed, or the underprivileged;
- advancement of religion;
- advancement of education or science;
- erecting or maintaining public buildings, monuments, or works;
- lessening the burdens of government;
- lessening neighborhood tensions;
- eliminating prejudice and discrimination;
- defending human and civil rights secured by law;
- combating community deterioration and juvenile delinquency."

Charitable Organization Types

Private

- Typically one person, one family, or one corporation
- Large investment, dividends
- Makes grants
- Must distribute at least 5% of its funds
- High degree of personal control

Example:

- Gates Foundation
- Must distribute 5% of its assets

Public

- At least one-third of funds from public donations
- Regular donor solicitation
- Responsible to a diverse group of board of directors
- Must prove to the IRS that it is not a private foundation
- Direct activities

• Examples:

- Red Cross
- American Cancer Society (supports ~750 active grants)

Figure 2. Historical funding from big philanthropy to HBCUs: Grant dollars awarded




Figure 3. Recent funding to HBCUs with additional foundations in 2015-2019





Figure 4. Total grant dollars awarded by foundation type, 2015-2019


Figure 12. Top 25 HBCU recipients of foundation grant dollars, 2015-2019






Philanthropic Funds for Universities (2015 – 2019)


- Ivy League Schools
 - \$5,500 million
 - \$1,100 million per year
 - \$110 million per year per Ivy League school
- HBCUs
 - \$300 million
 - \$60 million per year
 - \$0.6 million per year per HBCU
- Average Ivy League received 180 times more than the average HBCU.
- There is a lot of potential to increase philanthropic funds for HBCUs.












More Recent Years

In the more recent years (especially after 2020), HBCU funding via individuals, independent foundations, and corporate foundations has substantially increased.

 Many of the awards focus on enhancing the diversity of workforce and reducing educational, economic, and health disparities.

Some examples will be presented in the following slides.



MSU Awards Since July 1, 2020

- 29 Awards from 20+ Foundations
 - 17 prime
 - 12 subaward
- Total dollar amount: \$4.4 million
 - 2% of all of our awards
- Individual award amounts
 - Mean = \$150,000
 - Median = \$25,000
 - Ranging: \$1,200 to 1 Million+

Budget Notes

Read the solicitation very well, and speak with the program officer.

Determine what is allowable.

- The budget is typically quite small. For Morgan awards:
 - Mean = \$150,000
 - Median = \$25,000
- F&A rates are typically low.

F&A Rates

We often accept low F&A rates for foundation awards.

- Low F&A
 - 26 (of 29) awards had an F&A < 16%
 - 15 were 0%, 11 more <= 16%
 - Total F&A = \$268,000
 - Mean F&A = 6%
- Ask for administrative personnel, if allowable and the award is large.

Availability of Funds (2020 Numbers)




• There were approximately 120,000 foundations in the United States.


- Total Assets > \$1200 billion (1.2 trillion)
- Total Giving = \$82 billion
- There are many foundations, with much money. Each person needs to find the right one.

Top 5 subject areas by dollar amount




Top 5 populations served by dollar amount





In order to analyze grantmaking priorities by U.S. funders, Candid examines all grants of \$10,000 or more awarded by 1,000 of the largest U.S.-based private and community foundations. These funders account for about half of all grantmaking dollars awarded by private and community foundations.


Top 5 support strategies by dollar amount



Over 26% of grant dollars from U.S. funders were awarded for international purposes



The median grant amount was \$35,000



1% of recipient organizations captured half of grant dollars



Stanford University received the highest number of grants. Seven of the top 10 grant recipients were elite universities.

Identify the Right Foundation and Cultivate a Relationship

- Identify the Right Source
 - Use software (PIVOT-RP, Candid, Others)
 - Learn about the mission of the foundation
 - Review their 990, or talk to someone, for average size of funds
- Identify the gatekeepers in the foundation and learn about their interests, both professional and personal
- Treat the funder as friends, not as ATM machines
 - Relationships should not be transactional
- Communicate your appreciation







Summary (1)

- There are thousands of foundations in the United States, and they distribute over \$80 billion per year. Much of these funds are for underprivileged populations.
- HBCUs, including Morgan, have historically received relatively little from foundations.
 Except for the past two years, this amount has been typically \$0.6 million per year per institution, of which only a small part has been for research and sponsored programs.
- Morgan has fared better than the average HBCU, but there is substantial room to grow.

Summary (2)

 Over the past three years, Morgan has received 29 awards from 20+ foundations, totaling \$4.4 million.

- The following steps will help in increasing this amount substantially:
 - Learning about the mission of these foundations
 - Setting up a search
 - Making meaningful connections with the program officers
 - Making a case that Morgan is an ideal environment to receive these funds
 - Maintaining a good relation
- Morgan does accept low F&A rates when working with foundations.
