Seminar Series Description:

These seminars are intended to enhance the capacity of newly hired tenure-track MSU faculty members to become stronger researchers and educators, and to become more familiar with the history, culture, and accomplishments of MSU. The seminars focus mostly on grant writing, but there are also several sessions on achieving excellence in higher education instruction. One session is dedicated to the history and mission of MSU, to provide context for the research and teaching missions.

Objectives for Grant Preparation:

- 1. Describe the life cycle of sponsored awards
- 2. Identify sources of grant funding, especially those that are targeted toward HBCUs and other minority-serving institutions
- 3. Learn more about funding opportunity announcements and how to read them
- 4. Write well-prepared proposals for sponsored projects
- 5. Prepare budgets for sponsored projects
- 6. Prepare other auxiliary material (e.g., biosketches, letters of collaboration) for grants
- 7. Network with peers, successful researchers at the university, and the D-RED staff

Objectives for Pedagogical Enhancement:

- 1. Discuss the concept of reflective teaching and how it is fostered at Morgan State University
- 2. Survey selected theory-grounded and effective practices in higher education instruction

Teaching Methods and Activities:

- 1. Lectures by the primary instructors and other experts
- 2. Assignments to identify opportunities and write proposals
- 3. Assignments to sign up for key research portals and databases
- 4. Presentations by the participants
- 5. Multiple choice questions (a mixture of simple and complex questions)
- 6. Engaging in-session activities
- 7. Active Learning
- 8. Projects

Desired Outcome for Grant Preparation:

Participants are required to:

- Have a proposal ready for submission by June 30, 2025.
- Identify 2 to 3 additional funding opportunities and develop initial plans for submission.

Desired Outcome for Pedagogical Enhancement:

Participants will be able to:

- Describe the benefits of reflective teaching.
- Articulate an evidence-based understanding of metacognition, attention, and distraction.
- Define, compare, and contrast Behaviorism and Constructivism learning theories.
- Identify and differentiate between the levels of Bloom's Taxonomy.
- Distinguish between learning goals, objectives, and outcomes on a course syllabus.
- Recall and describe the three levels/aspects of classroom engagement.
- Explain 10 suggested inclusive practices for classrooms.
- Describe the concept of student assessment.
- Discuss the importance, forms, purposes, and methods of student assessment.
